### You understand and agree that:

- By signing this release form and attending the Project, you confirm you are the parent/legal guardian of the Child and in this capacity, authorise the Producer to record and edit the Child's likeness, image, voice and performance (Recordings).
- The Child's participation in this Project is voluntary and that you may withdraw consent at any time.
- The Recordings may be edited and otherwise altered at the discretion of the Producer, without needing further approval, and may be used in whole or in part for any and all broadcast, non-broadcast, advertising, social media, audio/visual, and/or exhibition purposes in any manner or media throughout the world. This includes materials produced for fundraising purposes.
- You agree that the Producer may use and authorise others to use all or parts of the Production and that the Producer, its successors and assigns shall own all rights, title and interest, including copyright to the Recordings without limitation.
- You agree that the Producer may store copies of the Recordings created and that they will store the contact details you have provided alongside this imagery in its database, and you consent to be contacted regarding the Recordings in the future. These contact details will not be shared with any third parties for other uses.
- If the Recordings are kept for longer than 5 years, the Producer will seek your consent again to use it.
